Consent for Purposes of Treatment, Payment and Healthcare Operations

I consent to the use or disclosure of my/my child's *Protected Health Information (PHI)* by Independent Educational Evaluators of America, LLC and IEEusa.net, for the purposes of (1) diagnosing and/or providing treatment to me/my minor child; (2) obtaining payment for my health care bills; and/or (3) to conduct routine health care operations. *PHI* means health information, and may include demographic information, collected from me and created or received by Independent Educational Evaluators of America, LLC and IEEusa.net, another health care provider, a health plan, my employer or a health care clearinghouse. This *PHI* relates to my/my child's past, present and/or future physical or mental health/condition and may identify me/my child.

I understand that diagnosis or treatment of me/my child by Independent Educational Evaluators of America, LLC and IEEusa.net may be conditioned upon my consent, as evidenced by my signature on this document. I further understand that I have the right to request a restriction as to how my/my child's *PHI* is used/disclosed to carry out evaluation, treatment, intervention, payment or the healthcare operations of the practice.

Independent Educational Evaluators of America, LLC and IEEusa.net are not required to agree to the restrictions that I may request, however, if they do agree, the restriction is binding. I also have the right to revoke this consent, in writing, at any time, except to the extent that Independent Educational Evaluators of America, LLC and IEEusa.net have taken action in reliance upon this consent.

I understand that I have a right to review Independent Educational Evaluators of America, LLC and IEEusa.net *Notice of Privacy Practices (NPP)* prior to signing this document and acknowledge that a written copy of Independent Educational Evaluators of America, LLC and IEEusa.net *NPP* has been provided to me. The *NPP* describes the types of uses and disclosures of my (*PHI*) that will occur in treatment, payment of my bills and/or in the performance of health care operations at the office of Independent Educational Evaluators of America, LLC and IEEusa.net. The *NPP* for Independent Educational Evaluators of America, LLC and IEEusa.net is also provided at the office at 2818 Lititz Pike, Lancaster, PA on the website: www.margaretkay.com. This *NPP* also describes my rights and Independent Educational Evaluators of America, LLC and IEEusa.net duties with respect to my *PHI*.

Independent Educational Evaluators of America, LLC and IEEusa.net reserve the right to change the privacy practices that are described in the *NPP*, and I may obtain a revised *NPP* by accessing her website, calling the office and requesting that a revised copy be sent in the mail and/or asking for a copy at the time of my/my child's next appointment.

After you have signed this consent, you have the right to revoke it by writing a letter telling us you no longer consent. We will comply with your request about using or sharing your PHI from that time on, but we may have already used/shared some of the PHI and cannot retrieve what has already been shared. Please read this before you sign this Consent form. If you do not sign this consent form agreeing to our NPP, we cannot complete an evaluation for you/ your child or provide any psychological services to you.
